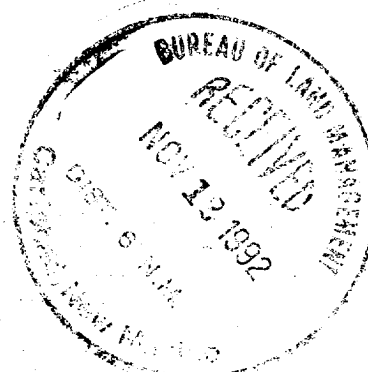

Resumed drilling 17-1/2" hole 11:00 AM 11-8-92. Ran 8 joints 13-3/8" 54.5# casing set at 330'. Guide shoe set 330', insert float set 287'. Cemented w/350 sx Class "C" with 2% CaCl₂ (yield 1.32, wt 14.8). PD 9:00 AM 11-9-92. Bumped plug to 600 psi, float held OK. Circulated 97 sacks to pit. WOC. Drilled out 3:15 AM 11-10-92. WOC 18 hours and 4 mins. Cut off and weld on flow nipple. Reduced hole to 12-1/4" and resumed drilling.
