4-15-93 Shot 1 JSPF @ 6840-47', 6933-39', 6962-64', 6967-74', 7077', 7080', 7085-7090', 7226-29', 7232-36', 7271-73', 7301-04', 7326-28', 7349-51', 7356-58', 7787-89', 7889-91', 7989-91', total of 70 holes. FL came up 450' after perf'ing PU & TIH w/5 1/2" cup type RBP + 5 1/2" Baker TST pkr on 252 jts. 2-7/8" tbq. Set RBP @ 8050'. Pull up & set pkr @ 7639' w/239 jts in and isolate perfs 7787-7991', 9 holes. Prep to acidize.

4-16-93 Acidized perfs 7787-7991' w/1000 gals 7 1/2% MCA triple inhibited acid, dropping 18 ball sealers. Avg press. 1850 psi. Poor ball action, opened to tank, swabbed.

4-19-93 Dropped down & released RBP. Pull up & set RBP @ 7450'. Set pkr & test RBP to 1000 psi, ok. Pull up & set pkr @ 7336' & isolate perfs 7349-7358'. Formation broke @ 4000 psi. Acidized perfs 7349-7358' (six holes) w/500 gals 7 1/2% mud clean out acid. Dropped 12 ball sealers. Acid on formation @ 2 BPM @ 4100 psi. Pull up & set pkr @ 7131' & isolate perfs 7226-7358', 25 holes. Load & pressured tbq - tbq would not hold.

4-20-93 Test tbq in hole above slips to 7000 psi. Set pkr above RBP. Tested to 4200 psi, held ok. Pulled up & set pkr @ 7336'. Unseat pkr. Moved up to 7131', pumped 5 bbls & press on back-side. Moved pkr up to 7003'. Pumped 500 gals 7 1/2% acid away. Swabbed & treated well w/2000 gals 7 1/2% mud acid & 60 ball sealers. Well treated @ rate/BPM. Max press 3686 psi. Avg press 1500 psi. Well balled out-48 balls on formation. Opened well, swabbed.
