SUNDRY NOTICE CONTINUED:

Neat cement plug from 7350-7201'. POOH qwith tubing. Cut 5-1/2" casing at 7008'. POOH with wireline and rigged down wireline. Could not pull. Shut well in for night.

4-25-2002 - Worked casing. Rigged up wireline. RIH with cutter and cut 5-1/2" casing at 6700'. POOH with wireline to 2642' and hung up tools. Lost tools. Rgged down wireline. Worked casing loose. Rigged up floor and 5-1/2" casing equipment. POOH with 50 joints of 5-1/2" casing. Shut well in for night.

4-26-2002 - POOH with 108 joints of 5-1/2" casing for a total of 158 joints. Rigged down casing equipment and floor. Nippled up 5-1/2" casing head and BOP. Rigged up 2-7/8" tubing equipment and floor. RIH with 80 joints of 2-7/8" tubing. Shut well in for night.

4-27-2002 - RIH with tubing to 6752'. Loaded hole with plugging mud. Spotted a 50 sack Class C Neat cement plug. POOH with 60 joints of tubing. WOC 4 hours. RIH with tubing and tagged plug at 6540'. POOH to 5709'. Shut well in for night.


4-27-29-2002 - Shut in over weekend.

4-30-2002 - Spotted a 50 sack Class C Neat cement plug from 5709-5514'. POOH to 3720'. Spotted a 50 sack Class C Neat cement plug from 3720-3525'. POOH to 1700'. Spotted a 50 sack Class C Neat cement plug. POOH with tubing. Shut well in for night.

5-1-2002 - RIH with tubing and did not tag plug. Spotted a 50 sack Class C Neat cement plug at 1700'. POOH with tubing. WOC 4 hours. RIH with tubing and tagged plug at 1540'. POOH to 395'. Spotted a 50 sack Class C Neat cement plug. POOH with tubing. WOC. Shut well in for night.

5-2-2002 - RIH with tubing and tagged plug at 195'. POOH with tubing. Rigged down tubing equipment and floor. Nippled down BOP. Cut off wellhead. Installed dry hole marker. Rigged down pulling unit and plugging equipment. PLUGGED AND ABANDONED - FINAL REPORT. Plugging completed May 1, 2002.

NOTE: Spotted a 20 sack Class C Neat cement plug at surface.
