Louis Dreyfus Natural Gas Corp. requests approval to dispose of water produced by the Ram Ewe Federal #2 into the Barbados State SWD (SWD #182). The water will be pumped through the flowline into a separator and then into the salt water disposal well. The Barbados State SWD well is operated by Louis Dreyfus Natural Gas Corp. and is located in the NE/4 SE/4 of Sec. 33-T22S-R26E, Eddy County, New Mexico.

If not disposed into the Barbados State well, the water will be trucked to a public salt water disposal well. The well has a water tank in which the water could be held until it is trucked.
