10-11-94 - Cleaned location, set and tested anchors and markers. Made cut off on 7" casing. Moved in and rigged up pulling unit. Nippled up tubinghead and installed BOP. TIH with bit, stabilizer, drill collars and 2-7/8" tubing to DV tool at 7010'. Rigged up power swivel. Drilled out DV tool at 7010'. Tested casing to 2000 psi, OK. TOOH with tubing, drill collars, stabilizer and bit. TIH with bit, scraper and 2-7/8" tubing to 8650'. Circulated casing with 2% KCL water. TOOH with tubing, scraper and bit. TIH with logging tool. Pressured casing to 1000 psi and ran CBL/CCL/GR log. TOOH with logging tool and rigged down wireline.

10-12-94 - TIH with 2-7/8" tubing to 8255'. Spotted 250 gallons 20% NEFE acid at 8255'. TOOH with 2-7/8" tubing. Rigged up wireline. TIH w/4" casing guns and perforated 8253-8256' w/8 .40" holes (2 SPF). TOOH with 4" casing guns and rigged down wireline. TIH with packer and 2-7/8" tubing. Set packer at 8190'. Tested packer to 1000#, OK. Swabbing.
