Released packer @ 7293' & POOH. PU BIT & DCs & RIH to 7615' & drilled out 10' of cement. POOH & RIH w/sandline drill bailer. Knocked out CIBPs @ 7625' & 7770'. Ran in to 7915' & drilled up CIBPs & float collar w/cement to 7970'. POOH & L/D collars & bit. RU wireline & perf. 7" casing from 7783'-94', 7720'-28', 7650'-7702', 7626'-42', 7586'-96', 7568'-80', 7544'-54', 7496'-7506', & 7416'-82' w/4 spf & 120 degree phasing. RD wireline. RIH w/PPI tool on 2-7/8" tbq. to 7818'. RU Howco & acidize perfs from 7416'-7794' w/50 gpf of 15% CCA HCl & additives. Flushed w/prod. water. PUH & reset packer @ 7348', load & test annulus, & fish valves. RD Howco. Swab well. POOH & L/D PPI tools. RIH w/bit & bulldog bailer on 2-7/8" tbq. Found bottom clean. POOH & L/D bailer. RIH w/RBP to 1530'. Set & tested. ND BOP, NU wellhead, NU BOP. RIH w/sub pump on 2-7/8" tubing. Set RBP @ 7978'. ND BOP & land tbq in wellhead. RD PU and turn well to production 2/21/99.
