PD 7:30 PM 5-1-2000. Bumped plug to 2175 psi for 5 minutes, OK. WOC. Released rig at 10:00 AM 5-2-2000.

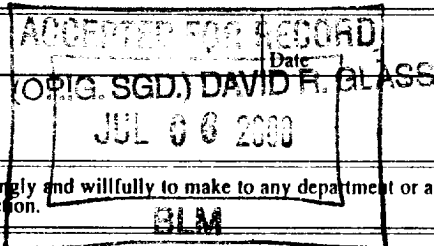
