Set packer at 665'. Acidized perforations 702-710' w/500 gallons 7-1/2% NEFE acid and ball sealers. Swabbed. Shut in.  
12-15-94 - Swabbed. Unset packer. TOOH with 2-3/8" tubing and packer. Shut down.  
12-16-94 - Shut in.
