1. POOH with pump and rods. Install BOP. POOH with tubing anchor and tubing.
2. TIH with bit, scraper and tubing to 7850'.
3. Perforate 7564-7650' (Canyon), acidize as necessary for production.
4. Swab test.
5. Pull all tools and return to production.
