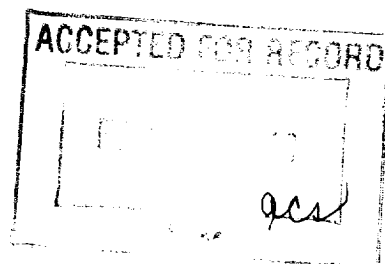

13. Describe Proposed or Recompleted Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Convert from flowing to artificial lift.

Trip out of the hole tubing and R-4 packer. Trip in the hole with submerible pump, shroud, cable and 2 7/8" tubing to 7344'. Nipple down BOP'S, install wellhead. Released rig.
