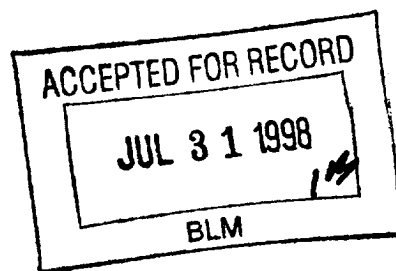

MIRU PU. Killed well. NU BOP. POOH w/2-7/8" tubing. RIH w/RBP and set @ 3210'. Tested & POOH. POOH w/killstring. RIH w/2 ODI P-7 pumps w/5-1/2" shroud on a total of 248 jts. 2-7/8" tubing to 3350'. Latched on to RBP. Released RBP and continued RIH. Landed bottom of RBP @ 7956'. Ran 3/8" stainless capillary tbg from 7865' to surface. Landed tbg in Seaboard head. ND BOP. NU head.
