Burlington Resources Oil and Gas Co. requests permission to plug back and abandon this well as follows:

TIH to PBTD (1927'). Circulate hole with clean gelled water. Set plug from 1536' to 1436' with 45 sxs Class C cement. Set CIBP at 1275'. RIH w/ 4" casing gun loaded 2 spf, 2 holes. Perforate at 900'. Spot 15 sxs (35') of Class C cement on top of CIBP. TOH to 900'. Open 9 5/8" x 13 3/8" annulus. Pump down tubing and establish circulation to surface. Set CICR at 850'. Pump 355 sxs Class C below CICR. TOH to 462'. Set plug from 462' to 362' with 45 sxs Class C cement. TOH with tubing to 50'. Spot 25 sxs Class C surface plug in 9 5/8" casing. Cut off all casing 5' below ground level. Weld on a steel plate on a casing stub. Reclaim as directed.
