11/18/98: Kill well. Install BOP. Pull tubing and lay down pump.

11/19/98: RU Wedge Wireline. Go in hole w/ gauge ring junk basket and collar locator. Hit bands at 8000'. POH & clean out junk basket, recovered bands off old pump. TIH to 8131' w/ junk basket. POH. RIH w/ RBP & set plug @ 8331'. Disposal zone plugged off.

11/21/98: RIH w/ new submersible pump. Put Indian Basin (Upper Penn) Assoc. zone back on production.

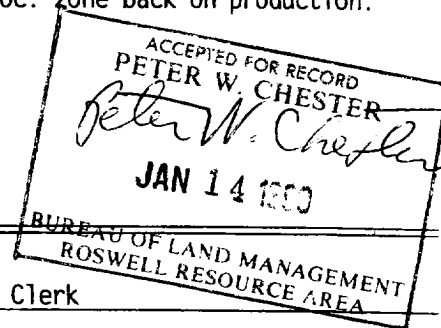
