Set CIBP @ 9,000'. Dump bail 35' of cement on top of plug. Spot 50 sks cements at 1650'. Spot 50 sks @ 370'. Circulate 10 sks at surface. Cap well, cut anchors off, clean location.

Note: Surface, both intermediate casing, 7 5/8" @ 9205' cemented to surface.
