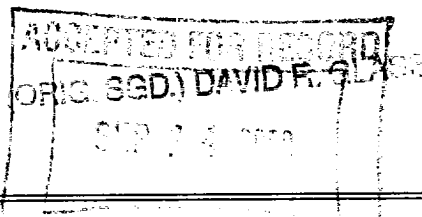

MIRU PU. Set frac tank. Kill Morrow and Strawn formations. RD tree. NU BOPE. Pull packer @ 10,428'. Set CIBP @ 10,840' to attempt water shutoff. Set 5 1/2" packer @ 9627', w/ 2-3/8" tailpipe to 10,800'. Avalon Morrow/West Burton Flat commingled below packer. Set 10,000# blanking plug in packer. Pressure test packer/wellbore to 1500 psi. Perforate Cisco/Canyon (see sundry). Pull blanking plug & land 2 7/8" tbg in pkr. Turn well to sales. Morrow/Strawn is commingled & produced up tbg. Cisco/Canyon perforations are isolated and produce up tbg/csg annulus.
