8/22/98 - Begin drilling 12 1/4" hole - lost 100% returns at 760'

8/23/98 - TD 12 1/4" hole at 1362' - run 32 joints - 9 5/8" - J55 - 36# - ST&C casing total pipe = 1368' set at 1362'. Cement with 200 sx "H" plus 10% Al₂O₃ plus 10# Gilsontite plus 1% CaCl₂ plus 1/4# celloflake plus 295 sx 35:65:6 "C" plus 5% salt plus 1/4# celloflake plus 150 sx "C" plus 2% CaCl₂ - DID NOT CIRCULATE

8/24/98 - Run temperature survey - TOC at 700' - begin 1" operations tag 1" at 704' - spot 4 - 25 sx plus 1-50 sx plugs at 704' with no fill Jim Amos - BLM ok'd dropping 5 buckets of gravel - spot 1 - 25 sx plug with fill to 600' - pump 225 sx cement and circulate 17 sx cement to surface

8/26/98 - WOC - 18 hours, NU BOP - test BOP to 3000 psi - good test
