Cemented csg with 250 sx 35:65 Cl "C" containing 2% CaCl2 and 1/4 pps Celloflake. Tail w/ 200 sx Cl "C" + 2% CaCl2. Circ'd 53 sx to pit. Plug down at 5:30 PM. WOC. Cut conductor off. Cement fell back to 100'. TIH w/ 1" pipe and pumped 50 sx cement, cmt circ'd to surface.

12/02/98: WOC. Tagged TOC @ 30'. Pumped 25 sx cmt thru 1" pipe & cmt circ'd. RD BJ Services. RD United Rig #9. Cut 9-5/8" csg off and weld on head. Tested weld, ok. Move sub off hole. MI Abbott Bros. rat hole machine. Drlg rat and mouse hole.

12/03/98: Rigging up McVay Rig #4.
