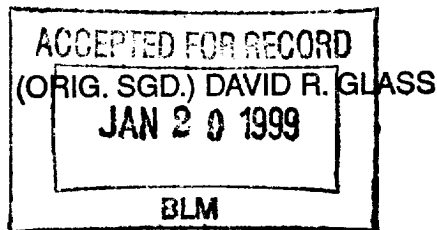

Plug down @ 2:00 PM MST. RD BJ. ND BOP, set slips w/ 205K. Cut csg off and NU tubing head. Tested head to 3000#, held ok. Jet and clean pits. Released rig at 7:00 PM MST. Waiting on completion unit.
