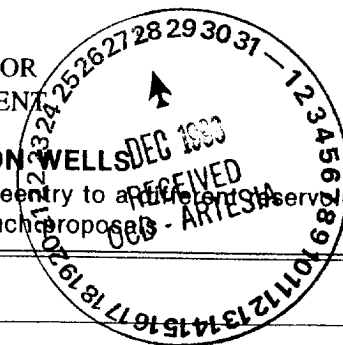

Bonneville Fuels Corporation requests the following amendments to its original Application for a Permit to Drill the subject well:

- The well name on the APD currently under your consideration will be changed from the Witt Fed. S.C. "30" - #1 to the Witt Federal "30" - #1.
- The Pro-Ration Unit for the well will be changed from a LAY-DOWN 320 acre spacing unit (north 1/2 of Section 30) requiring communitization with another Federal Lease and a State Lease (both in the NW 1/4 of Section 30) to a STAND-UP 320 acre spacing unit (east 1/2 of Section 30) which is all on Federal Lease NM84B.
