Cemented with 200 sacks "H", 10% A-10B, 10#/sack gilsonite, 1/4#/sack celloseal and 1% CaCl₂ (yield 1.52, weight 14.6) and 1018 sacks 65-35-6, 5#/sack gilsonite, 1/4#/sack celloseal and 2% CaCl₂ (yield 1.90, weight 12.7). Tailed in with 200 sacks "C" and 2% CaCl₂ (yield 1.34, weight 14.8). PD 8:30 AM 9-1-99. Bumped plug to 500 psi. Cement did not circulate. WOC 5 hours. Ran Temperature Survey and found top of cement at 750'. Ran 1". Tagged cement at 758'. Spotted 35 sacks "C" with 4% CaCl₂. PD 3:45 PM 9-1-99. WOC 2 hours. Ran 1". Tagged cement at 710'. Spotted 60 sacks "C" with 4% CaCl₂. PD 6:00 PM 9-1-99. WOC 2-1/4 hours. Ran 1". Tagged cement at 695'. Spotted 30 sacks "C" with 4% CaCl₂. PD 8:30 PM 9-1-99. WOC 3-1/2 hours. Ran 1". Tagged cement at 627'. Spotted 30 sacks "C" with 4% CaCl₂. PD 12:15 AM 9-2-99. WOC 2-1/2 hours. Ran 1". Tagged cement at 627'. Spotted 30 sacks "C" with 4% CaCl₂. PD 3:00 AM 9-2-99. WOC 2 hours. Ran 1". Tagged cement at 601'. Spotted 50 sacks "C" with 4% CaCl₂. PD 5:15 AM 9-2-99. WOC 1-3/4 hours. Ran 1". Tagged cement at 594'. Spotted 30 sacks "C" with 4% CaCl₂. PD 7:15 AM 9-2-99. WOC 2-1/2 hours. Ran 1". Tagged cement at 594'. Spotted 25 sacks "C" with 4% CaCl₂. PD 10:00 AM 9-2-99. WOC 1-3/4 hours. Ran 1". Tagged cement at 584'. Spotted 30 sacks "C" with 4% CaCl₂.
