When this well began producing earlier this year, it was not producing any oil so it was classified as a gas well. After producing for several months, the oil has begun to come in and has brought the GOR down to the point that this well needs to be reclassified as an OIL well. A recent test from this well is as follows:

9/27/99 - 154 BOPD, 1824 MCFD, & 5580 BWPD GOR = 11,884
