The Winston Gas Com. #8 spud on 05-15-2000 at 0330 hrs and drld a 12 1/4" hole to 1707'.

On 05-18-2000 ran 38 jts 9 5/8" 36# J-55 csg, set at 1706'; cemented w/200 sx Class H + 400 sx 35/65/6 Pozmix "C" + 200 sx Class "C"; TOC approx 500' by Temperature Svy. Cemented down 1" tbg w/458 sx Class "C"; TOC at surface (OK'd by Cathy Queen w/BLM). 18 hrs waited on cement to set and ran equivalency test.

Directionally drld 7 7/8" hole. Reached TD 9050' MD (8198' TVD) at 1200 hrs 06-13-2000.

On 06-18-2000 Schlumberger ran Platform Express Azimuthal Laterlog/Micro-CFL/GR and Three Detector Compensated Neutron/Litho-Density logs. On 06-19-2000 ran 201 jts 7" 26# and 23# K-55 csg, set at 9050' MD; cemented w/600 sx Pozmix "C", preceded by 50 BW + 45 bbls Turbo-flow spacer; TOC calc at 6000'. Released rig at 2000 hrs. WOCU.

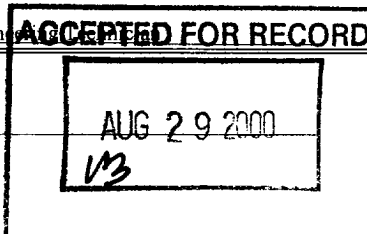
