2/12/00 Pump (3) 100 sack plugs down 1" @ 75' W/ 3% CC waiting 1 hr between plugs. WOC. Run temp svy TOC @ 100'. Pump 100 sx plug down 1" @ 75' W/ 3% CC WOC. Pump 90 sx W/ 3% CC down 1" @ 75', circ to surface. Release United Drilling Rig #4, waiting on Big rig to move in and continue drilling.
