Bumped plug. cmt did not circ. Tail w/ 200 sx Cl C + 2% CaCl. WOC. Run temp survey. PU 1" tbg and tag cmt at 495'.

5/21/00: RIH w/ 1" pipe and pumped 430 sx Cl "C" + 5% CaCl2 in 4 stages. Circ'd 5 sx to pit. RD and released rig at 6:00 a.m. Waiting on bigger rig.

5/08/00: MIRU McVay Rig #8.

5/10/00: NU BOP. Test blind rams, pipe rams, and manifold to 3000 psi, held okay. TTH w/ BHA. Resume
