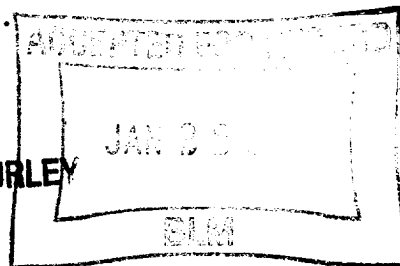

Stripped on stripping head, set PSL packer @ 9983' & loaded annulus. Tested annulus to 500 psi, spaced out, ND BOP, NU tree, & pulled plug. RU tree saver & Dowell. Acid frac'd Morrow zone (10-125'-10,284') w/24,500 gals. Titanate X-linked gel w/50% CO2, carrying 65,000 lbs. 20/40 sand. Screened out on 4 PPG sand. Avg rate 22 bpm @ 8500 psi. Flowed well back. RU coil unit w/BOP on tree. RIH & clean out tbg w/coil unit using Nitrogen and fresh water w/soap. RD Coil unit & flowed well to pit to clean out nitrogen and sand. Turned well over to production 1/6/01. Ran "After Frac Log" 1/16/01.
