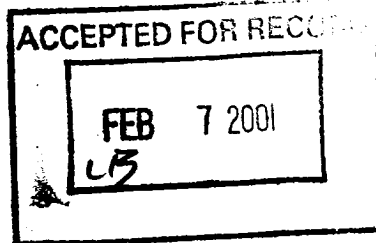

1/19/01 Ran mechanical integrity test on new disposal well. Pressured well up to 580 psi. Held for 30 minutes without any pressure drop. The chart is attached. The test was witnessed by Winston Ballard, Marathon Oil Company, and Phil Hawkins, New Mexico Oil Conservation Division. Injection into this well, as approved by Administrative Order SWD-784, began 1/24/01.
