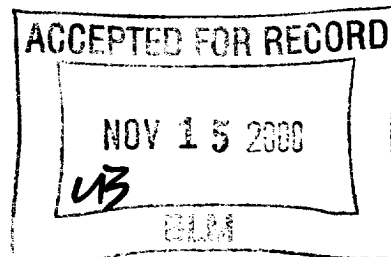

Cement 2nd stage using 250 sx 35/65 "C" poz + additives and 100 sx Class "C" + additives. Circ 110 sx cmt to surface. WOC 25 hrs. Cut off csg and weld on wellhead. NU BOPE and test.
