9/26/02 TIH with packer and 3-1/2" tubing. Will clean out with coil tubing to PBTD.
9/27-29/02 Moved in and rigged up pulling unit. Set packer at 8000' and tested to 750#.
9/30/02 Rigged up BJ 1-3/4" coil tubing. TIH with jet and coil tubing. Tagged at 8534'. Washed out bridge with N2 foamed 2% KCL water. Fell out at 8580'. TIH to PBTD at 9850'. Prep to TIH with coil tubing and pumped 15,000 gals 15% IC HCL.
10/1/02 TIH with 1-3/4" coiled tubing. Acidized Canyon with 15,000 gals 15% HCL 10,000 PPM IC. Pulled up. Let HCL set. Jet out HCL with N2. Rigged down coiled tubing. Rigged down pulling unit.
