10/14/02 Reached TD at 6:30 AM. Ran 34 joints 9-5/8" 36# J-55 (1512.29') casing set at 1501'. Texas Pattern Guide shoe set at 1501'. Float collar set at 1458'. Cemented with 200 sx "H" + additives (yld 1.52, wt 14.6) and 900 sx 35:65:6 with additives (yld 1.98, wt ??). Tailed in with 200 sx "C" + 2% CaCl2 (yld 1.32, wt 14.8). PD at 2:30 PM. Did not circulate cement. Ran Temperature survey, cement at 800'. Cemented stage 1 thru 1" with 25 sx Class "C" + 2% CaCl2. Tagged at 865'. Tagged cement at 859'. Cemented plug #2 with 25 sx Class "C" + 2% CaCl2. Tagged cement at 775'. Cemented plug #3 with 50 sx Class "C" + 2% CaCl2. Tagged cement at 754'. Cemented plug #4 with 50 sx Class "C" + 2% CaCl2. Tagged cement at 671'. Cemented stage 5 with 50 sx Class "C" + 2% CaCl2. Tagged cement at 660'. Cemented stage 6 with 50 sx Class "C" + 2% CaCl2. NOTE: Left message with BLM (Carlsbad) and notified of present operations. Corrected TD to 1501'.
