Plan to plug well as follows: Spot 25 sack cement plug at bottom of hole, 1910', knock off 7" casing at approximately 1400 feet. Run 15 sack cement plug on top of casing stub, fill hole with heavy mud and run 15 sack cement plug at bottom of 8 5/8" casing. Will put bull plug in top of 8 5/8" casing. Belle McCord, owner of surface rights, plans to make water well out of this hole.
