Spotted 30' cement plug 1770 to 1800'

Spotted 20' cement plug 1300 to 1320' below base of salt

Spotted 20' cement plug 1140 to 1160' above top of salt

Spotted 50' cement plug 525 to 575' in and below 8-5/8" casing, cemented at 555' with 50 sacks.

Cut and pulled 130' of 8-5/8" casing; set bridge & 5 sacks cement at 100'; filled hole to surface and set regulation market.
