November 21, 1957 - Acidized perfs 11,437-11,451' and 11,309-11,320' with 15,000 gallons mud acid.

November 24, 1957 - Acidized perfs 11,060-11,074' with 1000 gallons mud acid.

November 25, 1957 - Sandfraced perfs 11,437-11,451', 11,309-11,320' and 11,060-11,074' with 10,000 gallons of gelled kerosene.

Note: The intervals 11,437-11,451', 11,309-11,320' and 11,060-11,074' were perforated with 4 jet holes per foot.
