Cement plugs were placed at the following intervals: 0-10', 250-425', 2300-2450', 2500-2668'. Heavy mud laden fluid between plugs. Pulled 2188' of 5-1/2" casing 8-5/8" casing left in hole. Halliburton Oil Well Cementing Company performed the plugging operations. A 4-1/2" marker is erected at well site 5' above ground and filled with cement.
