FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Plug open hole section from csg. shoe @ 2729 to T.D. @ 2767 w/cement.
2. Shoot 7" csg. off @ top of cement and pull.
3. If 7" csg. is shot off below 8 5/8" csg. shoe, set a cement plug in bottom of 8 5/8" and top of 7" csg. If 7" csg. is shot off above 8 5/8" csg. shoe, salt section will automatically be isolated and cement plugs will not be required.
4. Set 10 sx cement plug in top of 8 5/8" csg. with 4' of 4" pipe protruding vertically above ground level.
