4. Install BOP & test casing to 600#.
5. Drill cement plugs set in 6-1/8" hole @ 380, 1050', 2750', & TD @ 4362'.
6. Drill new 6-1/8" hole from 4362' to 5050' & run electric logs.
7. Run & set 4-1/2" 10.5# casing to TD w/stage tool @ 3000' & cement 1st stage w/200 sx & 2nd stage w/330 sx.
8. RDMO rotary, install wellhead, run cement bond log, perforate & stimulate for salt water disposal. Subject to

INSTRUCTIONS
