1. Drilled to Total Depth of 2387' in barren Delaware Sand. Ran Electric Log.
Proposed plugging procedure:

1. Place 25 sk. cement plug at total depth.
2. Place 20 sk. cement plug at 2580' (Base of Salt)
3. Place 20 sk. cement plug across surface casing shoe (215')
4. Maintain hole full of drilling mud throughout operation.
5. Place 5 sk. plug at surface with marker pipe and fill pits and clean location.
