Cemented with 450 sacks Dowell lite wt. with 7.5# salt per sack and 200 sacks Class "C" with 2% CaCl. Circulated out 20 sx., left 30' cement in casing. Plug down at 11:18 a.m. 9-26-71. WOC 12 hours. Drilling ahead.
