It is proposed to remove the existing 2 7/8" tubing and 9 5/8" Husky M-1 packer at 12,233', then plug the Morrow using a CIBP at ±14,800' with 35' cement on top. Also plugs are to be set at the Penn - 13,200' (100' plug), 5 1/2" liner - 12,331' (50' inside and outside liner), Wolfcamp - 11,700' (100' plug in 9 5/8" casing).

The Delaware interval 5980-6560' will be converted to Salt Water Disposal under NMOC Administrative Order SWD-557.
