- Spot 40 sack plug from 1825 to 1925 feet. ~~6400~~ 4432
- Spot 55 sack plug from 266 to 366 feet.
- Place 5 sack plug at surface. Cut off wellhead. Weld on plate and dry-hole marker. Clean up location.
