8-4-79 Purpose of Operation: To commingle Morrow and Strawn zones. MIRU wireline truck. Ran 1-29/32" gauge ring and tagged cross-over @ 10,171' WLM. Ran equalizing prong and attempted to equalize casing and tubing. Tied tubing and casing together at surface and finished equalizing pressure. Ran 2" RS pulling tool and latched cross-over and TOH with dual type "S" cross-over. Ran 2" straight thru tool and sealed off top tubing ports. Strawn and Morrow zones commingled with flow thru tubing.

8-8-79 Llano, Inc. disconnected their station #158 and now measuring the commingled flow thru Station #157. Gas volume is allocated 34% Strawn and 66% Morrow. 100% liquid hydrocarbon to Strawn zone.
