WOC 9 hrs., West Engineering ran temp survey, TOC outside 5-1/2" csg at 9,250'. WOC 18 hours total, cut off csg and NU, tested csg w/1500# for 30 minutes, O.K.
Prep. to perforate and attempt completion.
