This well was drilled in 1973 by Texas American Oil Company. The location was stated on the location plats and permits as 660' FSL and 1650' FEL. The well was purchased by Devon Energy Corporation in 1988. Recently, we submitted a sundry notice to drill a well within 150' of the Todd "230" Federal #1 under the auspices of the "drilling pad". The new well, the Todd "230" Federal #5 was staked from the existing well. The actual surface location of the Todd "230" Federal #1 was found to be different than what was submitted to the BLM in 1973. The actual surface location of the well is:

748' FEL and 1665' FSL
