Please find attached the test results taken for this well during testing period approved by the BLM to determine the economical status of this well. As noted on the test results, we have a stabilized rate of 70 to 75 MCFPD. We are currently contacting gas pipeline companies to determine if they would tie-in and purchase this daily rate. Prize Operating respectfully request a 60 to 90 day time frame to get a gas purchase contract with a pipeline company. If this is not feasible, then Prize will submit a Sundry intent to Plug and Abandon the well. We are using the production from the Federal 'RR' #1 with this well in preparing a package deal with a pipeline.
