Application for permit to drill this well was filed April 4, 1978 and was approved April 10, 1978. The approval was valid for 90 days or until July 10, 1978 unless operations commenced. Due to delays beyond our control, we were not able to begin operations by the July 10, 1978 date. We now have all of our problems worked out and operations should begin within the next 30 days. Consequently, we are requesting that the commencement date of the permit be extended to August 20, 1978.
