Due to shortage of pipe, request permission to run 7 5/8" casing in two stages. First stage to be hung as a liner from approximately 3500' to 10,400', set with enough cement to fill annulus. Liner hanger is to have tieback tool. At a later date (when pipe is available) run sufficient 7 5/8" to tie into existing casing and circulate cement to surface.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
