2. Spotted 60 sacks class "H" cement @ 7933. Top of plug @ 7615 (wire line measurement).
3. Shot 7" casing off @ 7308 KBM and pulled 7" casing.
4. Spotted 65 sacks class "H" cement 7270-7120; 45 sacks plug 5803-5703; 45 sack plug 4306-4206; 50 sack plug 2683-2583; 50 sack plug 1310-1210; 50 sack plug 155-55. Finished plugging @ 12:30 p.m. 6-30-75.
5. Capped well w/10 sacks cement and installed 4' marker
