Ran 15 joints 13-3/8" casing bottom-to-top as follows: 2 joints (59.80'), 48#, N-40, ST&C, 8 joints (332.61'), 54.4#, K-55, ST&C, 5 joints (202.25'), 61#, K-55, ST&C, guide shoe, insert float collar, 3 centralizers and 1 cement basket. 13-3/8" casing set @ 595', insert float collar @ 536.96', centralizers @ 580, 560', 519', cement basket @ 243'. Cemented with 300 sx Class "C" with 1/2# celloflake/sx and 2% CaCl₂; tailed in with 400 sx Class "C" with 1/4# celloflake/sx and 2% CaCl₂. Good circulation throughout job. Cement circulated estimated 200 sx to pit. P.D. @ 6:10 P.M. MDT 7/12/74. W.O.C. 18 hours. N.U., pressure tested casing and B.O.P. to 800 psi for 30 minutes, held O.K.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
