This well was drilled to TD 4600' on 8-11-74 and the Delaware Formation tested dry. This well was plugged and abandoned as follows:

- 1) Spotted a 30 sack cement plug 4447-4550'.
- 2) Spotted a 100 sack cement plug 2612-2950'.
- 3) Spotted a 30 sack cement plug 372-475'.
- 4) Spotted a 30 sack cement plug surface to 100'.
- 5) Installed a dry hole marker.
- 6) Well plugged and abandoned 8-13-74.

All intervals not cemented were filled with 10.2# mud.
