WOC 24 hours. Tested BOP stack, choke manifold, lines, etc. to 5000 psi with H&R Testers. Tested casing to 1500 psi for 30 minutes -- held. Picked up and went in hole with drill pipe and drill collars - drilled plug, cement, float equipment and 47' of formation. Tested annulus to 1500 psi; bled to 1460 psi in 30 minutes. Drilling 8 1/2" hole.
