Propose to move in w/coil tubing unit and wash to 3350' w/wash tool on end of tubing using nitrified 2% KCL water for washing. (1) With coil tubing 20 feet below bottom perf, close off circ x wash perfs w/ foam consisting of nitrogen and acid A-Sol mixture. Liquid mixture to consist of 640 gals 7.5% HCL plus additives mixed w/2 drums Kelchem H-6142-2 x liquid pumped at 1/4 BPM x nitrogen at 200 SCFPM. Flush w/ 3 bbls foam. (2) Pull coil tbg 500' into 2 3/8" string x let acid spend for 30 minutes. Open return line and allow well to flow back on a 35/64 choke until liquid starts to return. (3) Adjust to open choke. When flow stops, pump nitrogen at 300 SCFPM. (4) RIH w/coil tubing 20' below bottom perf x circ 45 minutes. Repeat steps 1-4. POH w/coil tubing and return well to injection.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
